With reference to the above, this is to inform him that 18546.00 Qtls. ( eighteen thousand five hundred forty six Qtls) of food grains (Rice) under Mid-Day Meal scheme for Primary Schools and S.S.Ks for Class I-V, Upper Primary Schools and MSKs for class-V and Upper Primary Schools; MSKs for Class-VI-VIII and NCLP for Class II-IV for the month of September, 2011 is hereby sub-allotted to the Blocks and Municipalities of this District as per Annexure-I, Annexure-II and Annexure-III on the basis of the number of students in all Primary Schools, SSKs, Upper Primary Schools, MSKs and NCLP upto class-VIII.

He is requested to arrange for collection of R.O. of rice for Primary Schools, SSKs, Upper Primary Schools, & MSKs for Class I-V and Upper Primary schools and MSKs for Class-VI-VIII and NCLP for Class-II-IV under Mid-Day-Meal Scheme as per Block and Municipality wise breakup enclosed (Annexure-I, Annexure-II & Annexure-III) herewith and deliver the allotted quantities to the MR Distributors and ensure lifting of entire quantity and inform the undersigned of lifting.

It is to be ensured that fair average quality rice of Mid-Day Meal is received through joint sampling as per procedure prescribed by G.O. 137-SE(PInG)/MDM-13/10 Dated 23.03.2010. A specimen of joint sampling should be sent to Sri Soumyajit Debnath, WBCS (Exe), Officer in Charge, Mid-day Meal Scheme, Purba Medinipur and to all Sub-Divisional Officers with proper identification for future reference.
