



NOTIFICATION

No. 429/WB/2008 (Appellate): - In exercise of the powers conferred by sub-rule (1) of rule 23 of the Registration of Electors Rules, 1960 and in supersession of existing notification, the Election Commission hereby designates the District Election Officers of each district in the State of West Bengal as the Appellate Officer to whom an appeal shall lie from any decision of the Registration Officer under rule 20, rule 21 or rule 21 A of the said Rules of each of the Assembly Constituency comprised within that district, as determined by the Delimitation of Parliamentary and Assembly Constituencies Order No. 18 published in the official gazette on 15th February, 2006.
