





Sir,

Kindly note that the Personnel and Administrative Reforms Department, Government of West Bengal issued transfer orders for different posts held by the West Bengal Civil Service (Executive) Officers prior to the commencement of the process of the Special Summary Revision of Electoral Rolls with reference to 1.1.2012 as the qualifying date. It was expected that the entire process of movement of officers would be completed before the draft publication of the Electoral Rolls on 12 October 2011. However, in certain cases, the process could not be completed, as contemplated and there are some late release/ joining. Since the concerned posts are designated posts (ERO/ AERO) for the revision of electoral rolls, it would be appreciated if the Commission is moved to allow the movements (release/ joining/ taking over charge as ERO/ AERO) for the interest of public service. Since the positions mostly involve the Sub-divisional Officers/ Block Development Officers, special consideration may kindly be given to allow the proposed arrangements.
