

1 ..... 28.12.11	<p>I am hearing this petition in terms of order dated 07.09.2009 in WP no. 15353(W) of 2009 where the petitioner has represented that the licensee i.e. WBSEDCL has not taken steps to provide electricity connection to him. Ld. Advocate Shri Biswanath Sasmal represents the petitioner. Shri Sachinandan Dhara father of the petitioner Shri Mohan Dhara is present and has filed hazira that I accept. Private respondent, Shri Ranjan Kumar Maity is present today and has filed hazira that I accept.</p> <p>Shri Rabisankar Bera, Station Superintendent, WBSEDCL is also present and has submitted that there is a proposal to provide electricity connection to the petitioner. Thereafter there were certain difficulties in providing electricity connection apparently because of objection by Shri Maity. On 15.07.2010, BL&amp;LRO, Tamluk made a report saying that Mohan's father Shri Sachinandan Maity is in possession of the land from where connection can be given to him. The petitioner's father represents him today and has submitted that land is in his possession. Station Superintendent has agreed to provide connection and will send his agency to do the work within seven days for which site will be shown by the petitioner. This work will be implemented without fail and all are required to keep peace in the area.
