ORDER

On account of Indira Awaas Yojana, the total fund amounting to **Rs. 2,11,05,000/- (Rupees two crore eleven lakh five thousand)** only is hereby sub-allotted to 07 nos. of Panchayat Samities of Purba Medinipur district to their dedicated IAY bank Account for the year 2011-12 as per annexure attached.

The grant is towards the plan expenditure and will be utilised for the construction of new houses/Upgradation subject to the conditions laid down in the guidelines of Indira Awaas Yojana(IAY) from time to time.No deviation from the provisions of the guidelines is permissible.

Executive Officers are directed to prepare GP wise, category wise, sansad wise eligible beneficiaries list and to sanction IAY fund as per the allocation,after verification of such beneficiaries. They will cause send database of the same after disbursement to the Zilla Parishad.

1st & 2nd installment of fund will be distributed at Block level Campus to be attended by the beneficiaries and the Zilla Parishad members/functionaries, where the beneficiaries will be handed over the sanction letter as well as the cheque/information that the fund has been credited in their account in presence of Block Officials.

The terms & conditions are as follows :

1. The unit cost of construction of each new dwelling house is **Rs. 45000/-**(forty five thousand) as per the guidelines of IAY subject to the condition that the plinth area of the dwelling house should be not less than 20 (twenty) square meter.
2. The fund so allotted should be utilized in strict observance of the guidelines of Indira Awaas Yojana.
3. No contractor / middle man shall be engaged or the work shall not be executed departmentally by the Panchyats. The beneficiaries will construct their own houses.
4. After completion of the construction of the dwelling house the Gram Panchayat will affix a board on the wall of each such house showing the logo of IAY, the year of construction and the name of the beneficiaries concerned and the same will photographed alongwith the beneficiaries/Logo/building and sanitary latrine /Smokeless chullah as far as possible and will send some specimen photographs alongwith final UC.
5. The dwelling house so constructed will be in the name of female beneficiary member or both the female and male beneficiary members.
6. Diversion of this fund will in no way be entertained, whatsoever, the case may be.
