ORDER

Sanction is hereby accorded for the payment of ₹ 1,41,91,200.00 (Rupees One Crore Fourty One Lakh Ninety One Thousand Two Hundred) only out of approved AWP & budget of SSA for 2011-12 towards remuneration of 876 nos. of Primary Para Teachers out of 781 nos. of Primary Schools @ ₹ 5,400/- (Rupees Five Thousand Four Hundred) only per teacher per month for the month of October'11 to December'11 as per Memo No.273-SE(P)/PBRPSUS/ADMN/9/04-05 dated 23.04.2010 respectively should be strictly followed at the time of disbursement of remuneration.

The amount sanctioned above is being released by Account Payee cheque in favour of concern C.P.Cs. The operator(s) of the account will please withdraw the amount from the said bank account for disbursement of salary of Primary Para-Teachers through bank advice into their respective bank accounts.

The amount on account of P.Tax should be deducted from each Para-Teacher at the following rate and should be credited to the nearest Treasury under head of account "0028 – other Taxes on Income & Expenditure – 00-107-Taxes on Professions Trades, Callings & Employment".


Remuneration of Para Teacher's (Primary) will be disbursed by first working day of each month positively.

Rate of P. Tax to be deducted individually with effect from 28.03.2008.

P. Tax to be deducted

1. Pay ₹ 5001/- -6000/- ₹ 40/- (per month)

The Utilization Certificate is to be submitted to the District Project Office, Sarva Shiksha Mission, Purba Medinipur, month wise along with photocopy of acquaintance roll, attendance of Para-Teachers, Passbook, Order of sanction etc. in due course. No salary shall be released further if Utilization Certificate is not submitted in time.
