ORDER

In pursuance of Memo No. 1355 - ME dated 24.11.2010, and 818-ME dated 06.07.2011 issue by the Director of Madrasah Education, West Bengal, a total sum of Rs. 58 lakh (Rupees fifty eight Lakh) only has been allotted to the District Magistrate, Purba Medinipur under the head of a/c "2515-00-800-SP-031-31-02" towards payment of honorarium to the approved staff of Madrasah Shiksha Kendras. The fund is kept in the L.F. a/c of the District Magistrate, Purba Medinipur. Out of this fund an amount of Rs. 42,37,168.00 (Rupees forty two lakh thirty seven thousand one hundred sixty eight) only has already been disbursed for the purpose.

Now, out of the balance amount of Rs. 15,62,832 (Rupees fifteen lakh sixty two thousand eight hundred thirty two) only kept in the above said a/c, a sum of Rs. 11,15,190.00 (Rupees eleven lakh fifteen thousand one hundred ninety) only is hereby sub-allotted to the following approved Madrasah Shiksha Kendras towards payment of honorarium of the approved staff of MSK under the head of a/c "2515-00-800-SP-031-31-02".
